Nolley, Office Manager The Work Projects Administration, through the Veterans' Graves Registration Project, has made possible a survey of veterans' graves in Florida. The project's activities have not been confined to the graves and service records of Florida soldiers only, as it seemed fitting that a permanent record should be made of the grave of every American soldier who rests in Florida soil.

The permanent record thus compiled constitutes a valuable addition to the military records of Florida. Arrangements made by the Military Department with the Bureau of Vital Statistics of the State Board of Health ensure its maintenance as a continuing record.

The principal findings of the project's survey are being published in a Register of Deceased Veterans, in a series of sixty-seven registers. It is hoped that all persons interested in the military history of our State will be benefited by the publication of this series.

Adjutant General State of Florida The Veterans' Graves Registration Project is a statewide project in the Research and Records Section, Professional and Service Division, Work Projects Administration. It was organized by, and has operated under the sponsorship of the Military Department of the State of Florida and the co-sponsorship of the American Legion, Department of Florida.

We have attempted to prepare a comprehensive record of all graves of honorably discharged veterans of the United States (including Confederate Veterans) that may be found in Florida. The record compiled consists of a card giving all available data and their sources, concerning the service record and burial place of each veteran whose grave can be located, and plats of cemeteries in which such graves are to be found. Cards and plats are filed as permanent records in the office of the Adjutant General in the State Arsenal, St. Augustine, Florida.

The project wishes to record here its particular indebtedness to the Adjutant General and his staff for the invaluable
assistance they have rendered throughout the survey. Service and
patriotic organizations whose cooperation is gratefully acknowledged are The American Legion, Veterans of Foreign Wars, Disabled
American Veterans of the World War, United Spanish War Veterans,

#### CEMETERY LOCATION AND DIRECTIONS

W-11; P-1 CAXAMBAS CEMETERY

SECTION 7, TOWNSHIP 52, S., RANGE 26, E.

From Collier City on Marco Island, proceed south on road to Caxambas for a distance of 5 miles. Turn right (westerly) on obscure path, follow same to cemetery which lies on left.

NO BURIALS OF VETERANS REPORTED

W-11; P-2 COLLIER CITY CEMETERY

SECTION 7, TOWNSHIP 52, S., RANGE 26, E.

From Collier City, proceed southeasterly on the road to Caxambas for 2 and 3/10 miles. Cemetery lies on right.

W-11; P-3. ROSEMARY CUMETERY

SECTION 15, TOWNSHIP 49, S., RANGE 25, E.

From Naples, proceed north on U.S. Highway 494 (Tamiami Trail) for a distance of 5 miles. Cemetery lies to the right of and east of road.

BAPTIST CHURCH-COUNTY CEMETERY

SECTION 3, TOWNSHIP 47, S., RANGE 39, E.

From the post office in the town of Immokalee, proceed north on State Highway #164 for 1 and 3/10 miles to road on right. Then go 2/10 mile to cemetery which lies on right or south side of road.

NO BURIALS OF VETERANS REPORTED

#### W-11; P-5 SMALLWOOD (PRIVATE) CEMETERY

SECTION 36, TOWNSHIP 53, S., RANGE 29, E.

This cemetery is situated on the small island of Chokoloskee in a fishing village of same name. The island is reached by boat only and lies in Gulf approximately 3 miles south of the town of Everglades.

W-11; P-6 BROWN'S (PRIVATE) CEMETERY

SECTION 4, TOWNSHIP 47, S., RANGE 29, E.

From the post office in the town of Immokalee, go north 1 mile on State Highway #164, then turn right (east) and continue on same road 3/10 mile, then right again and go 1/10 mile to burial grounds which lie on left.

NO BURIALS OF VETERANS REPORTED

W-11; P-7 EPISCOPAL CEMETERY

SECTION 4, TOWNSHIP 47, S., RANGE 29, E.

From the post office in Immokalee, go on State Highway #164 for 4/10 mile. Burial ground lies on left or west side of highway.

NO BURIALS OF VETERANS REPORTED

W-11; P-8 FRAZIER'S CEMETERY

SECTION 1, TOWNSHIP 47, S., RANGE 30, E.

From the post office in the town of Immokalee, go east on a road which leads off of State Highway #164, (first road south of town) for a distance of 9 miles. Cemetery with 1 grave therein lies on left or north side of road.

HARKER (COLORED) CEMETERY

SECTION 32, TOWNSHIP 47, S., RANGE 30, E.

From the post office in the town of Immokalee, proceed south and easterly on State Highway #164 for a distance of 6 miles. Then turn left on dirt road for a distance of 200 feet. Burial ground lies on left of this road.
